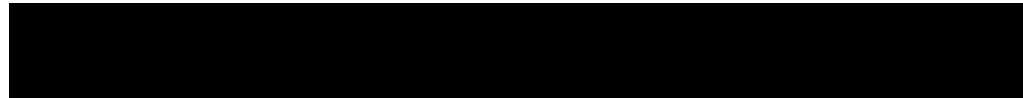

on or about July through October of 2017, in Madison County, Tennessee, and before the finding of this indictment, did knowingly obtain and/or exercise control over property, equal to or over the value of Ten Thousand Dollars (\$10,000.00), without the effective consent of the owner, to-wit: WEST BEMIS MIDDLE SCHOOL, with the intent to deprive the said owner thereof, in violation of T.C.A. §39-14-103, all of which is against the peace and dignity of the State of Tennessee.
