COUNT 1

The Grand Jurors for the State of Tennessee, duly elected, impaneled, sworn, and charged to inquire in and for the body of the County of Scott, in the State of Tennessee, upon their oath, present: That

AUSTIN ISAIAH LEWALLEN

prior to the finding of this indictment, on or about May 01, 2022 - January 31, 2023, in the County and State aforesaid, did unlawfully, feloniously, knowingly and without the effective consent of the owner, obtain or exercise control over funds on deposit with First National Bank, the property of Paint Rock Volunteer Fire Department, with the intent to deprive the said owner of the property, valued at \$10,000.00 or more but less than \$60,000.00, in violation of T.C.A. §39-14-103, and against the peace and dignity of the State of Tennessee.

COUNT 2

And the Grand Jurors aforesaid, upon their oaths aforesaid, do further present: That **AUSTIN ISAIAH LEWALLEN** prior to the finding of this indictment, on or about May 01, 2022 - January 31, 2023, in the County and State aforesaid, did unlawfully, feloniously, knowingly, and fraudulently use a debit card or information from that card, for the purpose of obtaining property, cash, services or anything else of value with knowledge that the use of the card was unauthorized by either the issuer, owner, or person to whom the debit card was issued, to wit: Paint Rock Volunteer Fire Department, and the value of said fraudulent use totaling more than \$10,000.00 but less than \$60,000.00, in violation of T.C.A. §39-14-118, and against the peace and dignity of the State of Tennessee.
