

CRIMINAL COURT FOR KNOX COUNTY, TENNESSEE

The Grand Jurors for the State of Tennessee, upon their oaths, present that AMY MICHELLE SHERROD, ALIAS, heretofore, to-wit: On divers and diverse days between the dates of January 2, 2012 and August 10, 2013, in the State and County aforesaid, did unlawfully and knowingly obtain and exercise control over property, to-wit: a quantity of good and lawful money of the United States of America, the further kinds, types, descriptions and denominations thereof to the Grand Jurors unknown, of the value of at least Ten Thousand and 00/100 (\$10,000.00) Dollars but less than Sixty Thousand and 00/100 (\$60,000.00) Dollars, of Carter High School Band Boosters without their effective consent, with intent to deprive the said Carter High School Band Boosters thereof, in violation of T.C.A. 39-14-103, and against the peace and dignity of the State of Tennessee.
