CHARGE: THEFT OVER \$1,000.00

The Grand Jurors of the State of Tennessee, duly summoned, elected, impaneled, sworn and charged to inquire in and for the body of the County aforesaid, in the State aforesaid, upon their oath, present that **CAROL PRITCHARD** heretofore, to wit; on or about a period of time from July 1, 2004 through October 31, 2006, in the County and State aforesaid and before the finding of this Indictment, did commit the offense of theft of property in the amount of one thousand dollars (\$1,000.00) but less than ten thousand dollars (\$10,000.00) by knowingly exercising or obtaining control over property to wit; monies totaling approximately eight thousand six hundred eighty-six dollars and sixty-two cents (\$8,686.62), the property of Cloudland Elementary/Carter County School System, without the owner's effective consent and with the intent to deprive the owner thereof; a class D felony, in violation of Tennessee Code Annotated 39-14-103, and against the peace and dignity of the State of Tennessee.
