





between November 15, 2005 and March 26, 2005 in Shelby County, Tennessee, and before the finding of this indictment, did unlawfully and with intent to defraud the Memphis City School System utter a forged writing to a representative of the System in a value in excess of \$1,000 but under \$10,000, to wit CAROLYN GREEN did provide a representative of the system with a deposit slip dated March 25, 2006 in the amount of \$9,250 to the account of Ms Green at Memphis Area Teachers' Credit Union, a letter from Memphis Area Teachers' Credit Union dated March 28, 2008 concerning the non availability of \$9,250 for fifteen days, and Check Number 205783 written to Kingsbury High School Senior Trip on the account of 3M Worldwide maintained at an account at Bank of America, when an original of the deposit slip, letter, and check, did not exist with the intent to defraud the representative of the system, in violation of T C A. 39-14-114, against the peace and dignity of the State of Tennessee



on April 21, 2006 in Shelby County, Tennessee, and before the finding of this indictment, did unlawfully and with intent to defraud the Memphis City School System utter a forged writing to a representative of the System in a value in excess of \$1,000 but under \$10,000, to wit CAROLYN GREEN did provide a representative of the System with an invoice number 1332 from Christian Chapel Charters which indicated that the account was paid in full when an original of the invoice did not exist with \$9,250 was still due on the account with intent to defraud the representative of the system, in violation of T.C.A. 39-14-114, against the peace and dignity of the State of Tennessee
