## State of Tennessee, Davidson County

### COUNT 1

THE GRAND JURORS of Davidson County, Tennessee, duly impaneled and sworn, upon their oath, present that:

#### **KECIA N. GRAY**


on divers day from the **14th** day of **August, 2006** through the **14th** day of **December, 2006**, in Davidson County, Tennessee and before the finding of this indictment, knowingly did obtain or exercise control over certain property, to wit: **money**, of the value of **\$10,000 or more but less than \$60,000**, the property of **Metropolitan Nashville Public Schools**, without the effective consent of **Metropolitan Nashville Public Schools**, with the intent to deprive **Metropolitan Nashville Public Schools** of the property, in violation of Tennessee Code Annotated §39-14-103, and against the peace and dignity of the State of Tennessee.

**COUNT 2**

THE GRAND JURORS of Davidson County, Tennessee, duly impaneled and sworn, upon their oath, present that:

**KECIA N. GRAY**

on divers day from the **14th** day of **August, 2006** through the **14th** day of **December, 2006**, in Davidson County, Tennessee and before the finding of this indictment, did intentionally or knowingly forge writings described or depicted as follows: **business records of the Maplewood Comprehensive High School Cafeteria** of the value of **\$10,000 or more but less than \$60,000**, with the intent to defraud or harm another, to wit: **Metropolitan Nashville Public Schools**, in violation of Tennessee Code Annotated §39-14-114, and against the peace and dignity of the State of Tennessee.
