AFFIDAVIT OF COMPLAINT

I, the affilant named below, after being sworn, state under oath that on or about September 2007 May 2009
 in Unicoi County, Tennessee, Bradley Terry Williams committed the offense(s) of
 violation(s) of T.C.A. § Theft over \$1,000.00 TCA 39-14-103 I further state under oath

that the essential facts constituting the offense(s), the sources of my information and the reasons why this information is believable and reliable are as follows:
 From the period of September 2007 to May 2009 the defendant did by his own admission use Band Booster funds to pay for his personal purchases on a credit card that was on the Band Booster account. Mr. Williams gave a statement to Tennessee Comptrollers office auditors that the card was used for Booster purposes and for his personal purchases. Mr. Williams also admitted in his statement that there was no resolution passed by the board or permission granted to allow him to use the card for personal purchases. Mr. Williams, in his statement, said that he did not know using the card for personal purchases was wrong however he did state that he knew using booster club funds to pay for it was wrong. According to the State of Tennessee audit there were \$10,199.30 in personal charges on the booster credit card, of these charges \$6,330.87 was paid by the booster club towards personal charges made by the defendant. On 6-30-2010 a check was given to the booster club by the defendant in the amount of \$6,330.87 to restitute the booster club account for the personal purchases made by the defendant. The above described acts are in violation of the listed Tennessee code.
