THE GRAND JURORS of Tipton County, Tennessee, duly empaneled and sworn, upon their oath, present that **ANDREA L. HOPKINS**, on or about March 18, 2017, in Tipton County, Tennessee, and before the finding of this indictment, did unlawfully, feloniously and knowingly, while a public servant, to-wit: Town of Burlison City Recorder, with intent to obtain a benefit, did receive a benefit, to-wit: a payment of \$653.85 in Town of Burlison funds to Orion Federal Credit Union for a personal car loan payment, not otherwise authorized by law, in violation of T.C.A. 39-16-402, against the peace and dignity of the State of Tennessee.

COUNT 2

And the Grand Jurors on their oath aforesaid further present that in Tipton County on or about March 18, 2017, before the finding of this indictment, the said **ANDREA L. HOPKINS**, did unlawfully and knowingly obtain property, to-wit: \$653.85 in Town of Burlison funds to Orion Federal Credit Union for a personal car loan payment, a more particular description thereof being to the Grand Jurors unknown, valued at one thousand dollars (\$1,000) or less, of the Town of Burlison without its effective consent, with the intent to deprive said Town of Burlison thereof, in violation of T.C.A. 39-14-103, against the peace and dignity of the State of Tennessee.

COUNT 3

And the Grand Jurors on their oath aforesaid further present that in Tipton County on or about March 24, 2017, before the finding of this indictment, the said **ANDREA L. HOPKINS**, did unlawfully, feloniously and knowingly, while a public servant, to-wit: Town of Burlison City Recorder, with intent to obtain a benefit, did receive a benefit, to-wit: a payment of \$3.94 in Town of Burlison funds to Cathy (CJ) Hayes, Greene County Tax Collector, State of Arkansas, for a personal tax liability, not otherwise authorized by law, in violation of T.C.A. 39-16-402, against the peace and dignity of the State of Tennessee.

COUNT 4

And the Grand Jurors on their oath aforesaid further present that in Tipton County on or about March 24, 2017, before the finding of this indictment, the said **ANDREA L. HOPKINS**, did unlawfully and knowingly obtain property, to-wit: \$3.94 in Town of Burlison funds to Cathy (CJ) Hayes, Greene County Tax Collector, State of Arkansas, for a personal tax liability, a more particular description thereof being to the Grand Jurors unknown, valued at one thousand dollars (\$1,000) or less, of the Town of Burlison without its effective consent, with the intent to deprive said Town of Burlison thereof, in violation of T.C.A. 39-14-103, against the peace and dignity of the State of Tennessee.

COUNT 5

And the Grand Jurors on their oath aforesaid further present that in Tipton County on or about August 7, 2017, before the finding of this indictment, the said **ANDREA L. HOPKINS**, did unlawfully, feloniously and knowingly, while a public servant, to-wit: Town of Burlison City Recorder, with intent to obtain a benefit, did receive a benefit, to-wit: a payment of \$89.90 in Town of Burlison funds to Results Physiotherapy, for a personal medical bill, not otherwise authorized by law, in violation of T.C.A. 39-16-402, against the peace and dignity of the State of Tennessee.

COUNT 6

And the Grand Jurors on their oath aforesaid further present that in Tipton County on or about August 7, 2017, before the finding of this indictment, the said **ANDREA L. HOPKINS**, did unlawfully and knowingly obtain property, to-wit: \$89.90 in Town of Burlison funds to Results Physiotherapy, for a personal medical bill, a more particular description thereof being to the Grand Jurors unknown, valued at one thousand dollars (\$1,000) or less, of the Town of Burlison without its effective consent, with the intent to deprive said Town of Burlison thereof, in violation of T.C.A. 39-14-103, against the peace and dignity of the State of Tennessee.
