THE GRAND JURORS of Crockett County, Tennessee, duly empaneled and sworn, upon their oaths, present that **STACEY MICHELLE SMALLWOOD** on or about July 1, 2011 and continuing through and including August 31, 2013, in Crockett County, Tennessee, and before the finding of this indictment, did unlawfully and knowingly obtain or exercise control over property, over the value of \$60,000.00, of Crockett County Emergency Communications District, without its consent, with intent to deprive the said owner thereof, in violation of T.C.A. §39-14-103, all of which is against the peace and dignity of the State of Tennessee;

COUNT TWO

And the Grand Jurors aforesaid, upon their oath aforesaid, present further that **STACEY MICHELLE SMALLWOOD** on or about July 1, 2011 and continuing through and including August 31, 2013, and in the aforesaid county, and within said jurisdiction, and before the finding of this indictment, did unlawfully and knowingly or intentionally and with intent to defraud or harm Crockett County Emergency Communications District and Bank of Crockett of the sum of over \$60,000.00, signed Brian Black's name on Crockett County Emergency Communications District checks without Brian Black's consent, so that said check purported to bear the signature of Brian Black as drawer/endorser, in violation of T.C.A. §39-14-114, all of which is against the peace and dignity of the State of Tennessee;

## COUNT THREE

And the Grand Jurors aforesaid, upon their oath aforesaid, present further that **STACEY MICHELLE SMALLWOOD** on or about July 1, 2011 and continuing through and including August 31, 2013, and in the aforesaid county, and within said jurisdiction, and before the finding of this indictment, did unlawfully and knowingly while a public servant, to wit: Administrative Director of Crockett County Emergency Communications District, with intent to obtain a benefit or to harm Crockett County Emergency Communications District, commit an act relating to her, the said **STACEY MICHELLE SMALLWOOD's** employment that constitutes an unauthorized exercise of official power, or intentionally or knowingly received any benefit not otherwise authorized by law, or violated a law relating to **STACEY MICHELLE SMALLWOOD's** office or employment, in violation of T.C.A. §39-16-402, all of which is against the peace and dignity of the State of Tennessee.
