THE GRAND JURORS of Overton County, Tennessee, duly empanelled and sworn upon their oath present that TARA SCOTT and LONNIE DEWAYNE SCOTT, from August 1, 2012 through May 1, 2014, in Overton County, Tennessee, and before the finding of this indictment, did unlawfully and knowingly obtain or exercise control over property owned by Hilham Elementary Parent/Teacher Organization, and valued at ten thousand dollars (\$10,000) but less than sixty thousand dollars (\$60,000.00), with intent to deprive the property owner and without the property owner's effective consent in violation of T.C.A. §39-14-103, and against the peace and dignity of the State of Tennessee.
