

CRIMINAL COURT FOR KNOX COUNTY, TENNESSEE

The Grand Jurors for the State of Tennessee, upon their oaths, present that MICHAEL C. JAMES, ALIAS, heretofore, to-wit: On or about the 1st day of July, 2014, and on divers and diverse days between that date and the 31st day of December, 2016, in the State and County aforesaid, did unlawfully and knowingly obtain and exercise control over property, to-wit: a quantity of good and lawful money of the United States of America, the further kinds, types, descriptions and denominations thereof to the Grand Jurors unknown, of the value of at least Sixty Thousand and 00/100 (\$60,000.00) Dollars but less than Two Hundred Fifty Thousand (\$250,000.00) Dollars, of Knox County Schools without its effective consent, with intent to deprive the said Knox County Schools thereof, in violation of T.C.A. 39-14-103, and against the peace and dignity of the State of Tennessee.
