

COUNT 1  
THEFT OVER \$2,500 BUT UNDER \$10,000

The Grand Jurors for Lewis County, Tennessee, duly impaneled and sworn, upon their oath, present that **TIMMIE LEON HINSON**, heretofore, to-wit, between September 01, 2016 and October 31, 2016, inclusive, before the finding of this presentment, in said County and State, did unlawfully, feloniously and knowingly obtain or exercise control over property, to wit: U.S. currency, of a value of at least \$2,500 but less than \$10,000, without the effective consent of the owner, Lewis County Soil Conservation District, and with the intent to deprive the owner thereof, in violation of Tennessee Code Annotated 39-14-103, a class D felony, and against the peace and dignity of the State of Tennessee.
