On or between January 1, 2012, and February 28, 2013, in McMinn County, Tennessee, and before the finding of this indictment, did unlawfully and knowingly obtain or exercise control over certain property, to-wit: Cash, valued at one thousand dollars (\$1,000.00) or more but less than ten thousand dollars (\$10,000.00), of Union Grove Volunteer Fire Department without the effective consent of anyone with authority to do so, with intent to deprive the said Union Grove Volunteer Fire Department of the property, in violation of T.C.A. 39-14-103, all of which is against the peace and dignity of the State of Tennessee.


