ORDER AND CERTIFICATION OF ASSESSMENT

On or about Monday, August 2, 2010, the Comptroller of the Treasury (Comptroller), by and through the Office of State Assessed Properties (OSAP), notified all public utility and transportation companies in Tennessee of their 2010 ad valorem tax assessments pursuant to T.C.A. Section 67-5-1327(a). OSAP further notified county and municipal governments of the completion of the 2010 assessments. Pursuant to T.C.A. Section 67-5-1327(b), any company, county or municipality may present evidence to the Comptroller concerning the assessment made by the Comptroller. Comptroller Justin P. Wilson appointed Mr. Tom Fleming as his designee to examine evidence and exceptions filed.

All exceptions were reviewed as well as all late-filed ad valorem reports for 2010. In addition, the staff of OSAP submitted new recommendations for other public utility and transportation companies. OSAP reserved its right to challenge the jurisdiction of any exceptions that may later be discovered to have been untimely filed.

The Comptroller's Designee held a hearing on Wednesday, August 18, 2010, to permit companies, counties or municipalities who filed exceptions to appear and present additional evidence and argument. Having considered the exceptions filed by protesting

companies, the recommendations made by the staff of OASP, and the evidence submitted at the August 18, 2010 hearing, including all written and oral evidence presented by all parties, the Comptroller's Designee hereby certifies to the Tennessee State Board of Equalization (Board) the assessments listed in the "Certification of 2010 Ad Valorem Assessments by the Comptroller of the Treasury" dated September 7, 2010. In support of this Order and Certification of Assessment, I make the following findings and conclusions:

I. Airline Company Exceptions

Atlantic Southeast Airlines (Atlantic) filed a written exception to its assessment. Atlantic's written exception claims that the assessment by OSAP exceeds market value as defined by Tennessee law. No evidence was submitted by Atlantic that would support any claim for relief. However, a new recommendation was provided to me by the OSAP. I hereby accept this new recommendation and find that Atlantic's value for 2010 is \$5,168,700. Therefore, to the extent Atlantic is requesting relief and having filed its exception with the Comptroller for the purpose of preserving its right to raise the issue again before the State Board of Equalization, I note Atlantic's exception but decline to grant the relief which it seeks.

ExpressJet Airlines, Inc. (ExpressJet) filed a written exception to its assessment. ExpressJet's written exception claims that its property has been assessed at a value in excess of its actual fair market value. No evidence was submitted by ExpressJet that would support any claim for relief. Therefore, to the extent that ExpressJet is requesting relief and having filed its exception with the Comptroller for the purpose of preserving its

right to raise the issue again before the State Board of Equalization, I note ExpressJet's exception but decline to grant the relief which it seeks.

SkyWest Airlines, Inc. (SkyWest) filed a written exception to its assessment. SkyWest's written exception claims that the assessment by OSAP exceeds market value as defined by Tennessee law. No evidence was submitted by SkyWest that would support any claim for relief. However, a new recommendation was submitted to me by the OSAP. I hereby accept this new recommendation and find that SkyWest's value as of 2010 is \$5,180,300. Therefore, to the extent that SkyWest is requesting relief and having filed its exception with the Comptroller for the purpose of preserving its right to raise the issue again before the State Board of Equalization, I note SkyWest's exception but decline to grant the relief which it seeks.

II. Barge Line Company Exceptions

U.S. United Barge Line (United), f/k/a/ TECO Barge Line, filed a written exception to its assessment. The Tennessee Court of Appeals has recently opined that United is assessable as a barge line company in Tennessee. However, United will be filing an appeal with the Tennessee Supreme Court challenging this decision. A decision by the Tennessee Supreme Court would determine the outcome of the issues presented by United in its written exception for 2010. Therefore, I note United's exception but decline to grant the relief which it seeks.

Chattanooga Riverboat Company (Chattanooga) filed a written exception to its assessment. Chattanooga's written exception did not state any reason or basis for the exception. No evidence was submitted by Chattanooga that would support any claim for relief. Therefore, to the extent that Chattanooga is requesting relief and having filed its

exception with the Comptroller for the purpose of preserving its right to raise the issue again before the State Board Equalization, I note Chattanooga's exception but decline to grant any relief.

Volunteer Princess Cruises, LLC (Volunteer) filed a written exception to its assessment. Volunteer's exception claims the following: (1) the assessment far exceeds the fair market value of the assets appraised; (2) the assessment is not supported by any generally accepted appraisal approach, including the market, cost, or income approach; (3) the assessment is inconsistent with and incompatible with previous assessments established by the OSAP; and (4) the assessment fails to take into consideration and provide reasonable weight to the income approach in the valuation of the assets at issue, in that the income approach would clearly demonstrate that the assets have a nominal value. No evidence was submitted by Volunteer that would support any of its claims for relief. Therefore, to the extent that Volunteer is requesting relief and having filed its exception with the Comptroller for the purpose of preserving its right to raise the issue again before the State Board Equalization, I note Volunteer's exception but decline to grant any relief.

III. Electric Company Exceptions

Kingsport Power Company (Kingsport) filed a written exception to its assessment. Kingsport is requesting a fifteen percent (15%) reduction to its personal property by virtue of a settlement agreement entered into with the Tennessee State Board of Equalization some years ago. As it is the State Board of Equalization that provides this reduction, I decline to grant the relief which Kingsport seeks.

IV. Motor Carrier Company

Con-Way Transportation Services, Inc. (Con-Way) filed a written exception protesting that some of its properties had been assessed at values in excess of their actual market values. No evidence or testimony was presented that would support any claim for relief. Therefore, to the extent that Con-Way is requesting relief and having filed its exception with the Comptroller for the purpose of preserving its right to raise the issue again before the State Board Equalization, I note Con-Way's exception but decline to grant any relief.

V. Pipeline Company Exceptions

Colonial Pipeline Company (Colonial) filed a written exception claiming that the classification of certain of its properties as real property instead of personal property is unconstitutional. In addition, Colonial also excepts to any assessment ratio that results in an assessment in excess of 30% of value for personal property and 40% of value for real property and excepts to any local jurisdiction contesting Colonial's right to any personal property equalization relief, including equalization relief at the 15% level for centrally assessed personal property, which was granted by the State Board of Equalization beginning in 1997. It appears that the issues being raised by Colonial are the same issues that have been raised every year since 2004. Furthermore, Colonial has a lawsuit pending in Davidson County Chancery Court concerning these issues. No evidence or testimony was presented by Colonial that would support any claim for relief. Therefore, to the extent that Colonial has filed an exception, I note Colonial's exception but decline to grant the relief which it seeks.

Tengasco Pipeline Corporation (Tengasco) filed a written exception claiming that the assessed value is excessive of the value of its system. A new recommendation was

submitted by the OSAP for Tengasco. I hereby accept this new recommendation and find that Tengasco's value for 2010 is \$2,502,500. To the extent Tengasco wishes to preserve its right to appeal on to the State Board of Equalization, I decline to grant any further relief.

VI. Power Transmission Company Exceptions

Appalachian Power Company (APC) filed a written exception to its assessment. APC is requesting a fifteen percent (15%) reduction to its personal property by virtue of a settlement agreement entered into with the Tennessee State Board of Equalization some years ago. As it is the State Board of Equalization that provides this reduction, I decline to grant the relief which APC seeks.

VII. Wireless Carrier Company Exceptions

Sprint Nextel Wireless (Sprint) filed a written exception to its assessment. Sprint is protesting its value as of January 1, 2010. No testimony or evidence was submitted by Sprint to support its claim for any relief. However, a new recommendation was submitted to me by the OSAP. I hereby accept this new recommendation and find Sprint's value for 2010 is \$70,200,000. Therefore, to the extent that Sprint is requesting relief and having filed its exception with the Comptroller for the purpose of preserving its right to raise the issue again before the State Board Equalization, I note Sprint's exception but decline to grant any relief.

VIII. NEW RECOMMENDATIONS

New recommendations were presented to me by OSAP. Various reasons for the new recommendations included (1) companies that filed a late ad valorem report, (2) companies that amended an ad valorem report, (3) companies that submitted additional

information, (4) OSAP correcting clerical errors, (5) companies that were discovered to be out of business, and (6) newly discovered companies. OSAP informed me that each of the companies listed on the new recommendations list were informed, either by phone or e-mail, of their assessments. No objection being heard on the new recommendations by any person or entity I hereby accept the new recommendations list by OSAP. The new recommendations are attached to this order and are hereby made a part of this order.

Therefore, based on the evidence presented to me in this proceeding, I, Tom Fleming, being the Designee of the Comptroller of the Treasury, do hereby file with and certify to the State Board of Equalization the assessments for ad valorem taxation purposes made by the Comptroller for tax year 2010 of the properties belonging to all public utility and transportation companies including those persons or entities that filed an exception. In addition, I do hereby file with and certify to the State Board of Equalization the assessments made in the new recommendations list for ad valorem taxation purposes made by the Comptroller for tax year 2010. The attached certification incorporates all of the assessments of all public utility and transportation companies and the findings from the hearing of August 18, 2010, as well as any additional evidence that was filed.

Conclusions

I certify that these assessments are true and correct to the best of my knowledge and belief. Any party aggrieved with the Comptroller's decision in this matter has the right of de novo review before the Tennessee State Board of Equalization in accordance with the procedural rules of the Board.
