ORDER AND CERTIFICATION OF ASSESSMENT

On or before Monday, August 3, 2015, the Comptroller of the Treasury, by and through the Office of State Assessed Properties (hereafter referred to as "OSAP"), notified all public utility and transportation companies of their 2015 ad valorem tax assessments pursuant to Tenn. Code Ann. § 67-5-1327(a). OSAP also notified county and municipal governments of those assessments. Under Tenn. Code Ann. § 67-5-1327(b), "any owner, or user, the state or any county, municipality, or incorporated town may appear and file exceptions" to such assessments at an informal hearing convened by the Comptroller. By letter dated June 9, 2015, Comptroller Justin P. Wilson appointed me, Bryan Kinsey, as his designee to examine any exceptions to the assessments and to review any new recommendations from OSAP's staff. Taxpayers had until Wednesday, August 12, 2015 to file exceptions with the Comptroller.

I held the hearing on Wednesday, August 19, 2015 in Room 31 of the Legislative Plaza to permit anyone who filed exceptions to appear before me and present any evidence. After considering the exceptions filed, new recommendations by OSAP, and evidence submitted, I hereby certify to the Tennessee State Board of Equalization the assessments listed in the "Certification of 2015 Ad Valorem Assessments by the

Comptroller of the Treasury” dated August 31, 2015. In support of this Order and Certification of Assessment, I make the following findings and conclusions:

I. County Official Exceptions:

McNairy County filed a written exception, made an appearance at the hearing and took exception to the \$36,062,000 assessment of Pickwick Electric Cooperative.

Smith County filed a written exception, made an appearance at the hearing and took exception to the \$65,782,000 assessment of Upper Cumberland Electric Membership Corp.

McNairy County and Smith County claim that “the assessment fails to properly assess all of the property owned by [the electric utility] in accordance with the Constitution of the State of Tennessee and Tennessee law by excluding property reported as miscellaneous physical property (Item #13 on Balance Sheet Assets – Form CT-0399)”. At the hearing, OSAP stated that it properly identified exempt property pursuant to Tenn. Code. Ann. § 65-25-222(a). To the extent that McNairy County and Smith County filed an exception, I note the exception but decline to grant any relief.

II. Air Freight Company Exceptions:

Federal Express Corporation filed a written exception to OSAP’s \$891,069,200 assessment of property, but did not make an appearance at the hearing. At the hearing, OSAP presented a new recommendation of \$796,384,000 and stated that after numerous points of contact, including desk audits of the company’s filings for 2015 as well as amendments and corrections submitted by Federal Express, OSAP found some discrepancies in the 2015 filings. The new recommendation, according to OSAP, is the best assessment for the company for 2015. To the extent that Federal Express

Corporation wishes to go forward with its appeal, I note the exception but decline to grant any relief.

III. Barge Line Company Exceptions:

Volunteer Princess Cruises, LLC filed a written exception to OSAP's \$568,000 assessment of property, but did not make an appearance at the hearing. In the exception, Volunteer Princess Cruises claims, "This value is in our opinion totally inconsistent with the value of this property operating in the State of Tennessee. This takes into account the heavy tax burden placed upon this operation and the extreme pressure caused by economic obsolescence." To the extent that Volunteer Princess Cruises, LLC wishes to go forward with its appeal, I note the exception but decline to grant any relief.

IV. Pipeline Company Exceptions:

Colonial Pipeline Company filed a written exception to OSAP's \$70,000,000 assessment of property, made an appearance at the hearing and claims, among other things, that: (1) the classification of some of its properties as real property instead of personal property is unconstitutional; (2) the assessment is made pursuant to an unconstitutional act passed by the Tennessee General Assembly in 2004 allegedly attempting to reverse a decision by the Tennessee Court of Appeals finding that Colonial's pipeline system is personal property; and (3) any assessment ratio that results in an assessment in excess of 30% of value for personal property and 40% of value for real property violates Colonial's constitutional rights. Colonial also excepts to any local jurisdiction contesting Colonial's right to any personal property equalization relief, including equalization relief at the 15% level for centrally assessed personal property, which was granted by the State Board beginning in 1997. The issues being raised by

Colonial are the same issues that have been raised annually since 2004. Furthermore, Colonial has a suit pending in Davidson County Chancery Court concerning these issues. To the extent that Colonial filed an exception, I note Colonial's exception but decline to grant any relief.

Renewco-Meadow Branch, LLC filed a written exception to OSAP's \$5,780,000 assessment of property, but did not make an appearance at the hearing. On August 17, 2015, Renewco-Meadow Branch withdrew its appeal and accepted the value proposed on Friday, August 14, 2015 for an unequalized assessment of \$4,790,000.

V. New Recommendations


OSAP presented new recommendations to me for various reasons: (1) companies filed late reports; (2) companies amended reports; (3) OSAP discovered companies are private carriers; (4) OSAP corrected clerical errors; (5) OSAP discovered companies that were out of business; (6) OSAP discovered new companies; (7) the value of land increased; and (8) OSAP adjusted real property. OSAP testified that it notified each company on the new recommendations list of the new recommendations and that the companies accepted the new assessments. No one made any objections concerning the new recommendations. Therefore, I hereby accept the new recommendations list by OSAP. The new recommendations are attached to and made a part of this order.

Based on the evidence presented to me in this proceeding, I, Bryan Kinsey, being the designee of the Comptroller, do hereby file with and certify to the State Board of Equalization the assessments for ad valorem taxation purposes made by the Comptroller for tax year 2015 for all public utility and transportation companies. I also certify to the State Board of Equalization the assessments in the new recommendations list for tax year

2015. The attached certification incorporates all of the assessments of all public utility and transportation companies and the findings from the hearing on Wednesday, August 19, 2015, as well as any additional evidence that was filed.

VI. Conclusions

I certify that these assessments are true and correct to the best of my knowledge and belief. Any party aggrieved with the Comptroller's decision in this matter has the right of *de novo* review before the Tennessee State Board of Equalization in accordance with the procedural rules of the Board.
