
THE GRAND JURORS of Fayette County, Tennessee, duly empaneled and sworn, upon their oath, present that **JIMMY TAYLOR WILSON**, on or about August 01, 2016, in Fayette County, Tennessee, and before the finding of this indictment, did unlawfully, feloniously, and knowingly exercise control over property, to-wit: U.S. currency, a more particular description thereof being to the Grand Jurors unknown, valued at over two thousand five hundred dollars (\$2,500) but less than ten thousand dollars (\$10,000), of Fayette County School System without its effective consent, with the intent to deprive said Fayette County School System thereof, in violation of T.C.A. 39-14-103, against the peace and dignity of the State of Tennessee.

## COUNT 2

And the Grand Jurors on their oath aforesaid further present that in Fayette County on or about August 01, 2016, before the finding of this indictment, the said **JIMMY TAYLOR WILSON**, did unlawfully, feloniously, and knowingly while a public servant, with intent to harm another, commit an act relating to the servant's office or employment that constitutes an unauthorized exercise of official power, in violation of T.C.A. 39-16-402(a)(1), against the peace and dignity of the State of Tennessee.

## COUNT 3

And the Grand Jurors on their oath aforesaid further present that in Fayette County on or about August 01, 2016, before the finding of this indictment, the said **JIMMY TAYLOR WILSON**, did unlawfully, knowingly, and intentionally destroy, conceal, remove or otherwise impair the verity, legibility or availability of a government record, in violation of T.C.A. 39-16-504(a)(3), against the peace and dignity of the State of Tennessee.
