THE GRAND JURORS of Crockett County, Tennessee, duly empaneled and sworn, upon their oaths, present that **MICHAEL GLENN MANESS** during the period of December 01, 2014 through March 31, 2018, in Crockett County, Tennessee, and before the finding of this indictment, did unlawfully and knowingly obtain or exercise control over property, sixty thousand dollars (\$60,000.00) or more but less than two hundred and fifty thousand (\$250,000.00) in value, of Crockett County School System without its effective consent, with intent to deprive Crockett County School System thereof, in violation of T.C.A. 39-14-103, all of which is against the peace and dignity of the State of Tennessee;

COUNT TWO

And the Grand Jurors aforesaid, upon their oath aforesaid, present further that **MICHAEL GLENN MANESS** during the period of December 01, 2014 through March 31, 2018, and in the aforesaid county, and within said jurisdiction, and before the finding of this indictment, while a public servant, to wit: Technology Coordinator for Crockett County School System, with intent to obtain a benefit or to harm another, did intentionally or knowingly commit and act relating to his, employment that constitutes an unauthorized exercise of official power, in violation of T.C.A. 39-16-402(a)(1), all of which is against the peace and dignity of the State of Tennessee;

COUNT THREE

And the Grand Jurors aforesaid, upon their oath aforesaid, present further that **MICHAEL GLENN MANESS** during the period of December 01, 2014 through March 31, 2018, and in the aforesaid county, and within said jurisdiction, and before the finding of this indictment, while a public servant, to wit: Technology Coordinator for Crockett County School System, with intent to obtain a benefit or to harm another, did intentionally or knowingly, commit an act under color of office or employment that exceeds the servant's official power, in violation of T.C.A. 39-16-402(a)(2), all of which is against the peace and dignity of the State of Tennessee;

COUNT FOUR

And the Grand Jurors aforesaid, upon their oath aforesaid, present further that **MICHAEL GLENN MANESS** during the period of December 01, 2014 through March 31, 2018, and in the aforesaid county, and within said jurisdiction, and before the finding of this indictment, while a public servant, to wit: Technology Coordinator for Crockett County School System, with intent to obtain a benefit or to harm another, did intentionally or knowingly violate a law relating to his public servant's office or employment, in violation of T.C.A. 39-16-402(a)(4), all of which is against the peace and dignity of the State of Tennessee;

COUNT FIVE

And the Grand Jurors aforesaid, upon their oath aforesaid, present further that **MICHAEL GLENN MANESS** during the period of December 01, 2014 through March 31, 2018, and in the aforesaid county, and within said jurisdiction, and before the finding of this indictment, while a public servant, to wit: Technology Coordinator for Crockett County School System, with intent to obtain a benefit or to harm another, did intentionally or knowingly obtain a benefit not otherwise authorized by law, in violation of T.C.A. 39-16-402(a)(5), all of which is against the peace and dignity of the State of Tennessee.
