COUNT THREE

THE GRAND JURORS OF CROCKETT COUNTY, duly empaneled and sworn upon their oath, present that the defendant, **APRIL HICKS**, between July 1st, 2018 and July 2nd, 2019, and before the finding of this indictment, the defendant, a public servant, with intent to obtain a benefit or to harm another, intentionally or knowingly, committed an act relating to the public servant's office or employment, being the offense of theft, that constitutes an unauthorized exercise of official power, in violation of T.C.A. §39-16-402, a Class E Felony, and against the peace and dignity of the State of Tennessee.

COUNT FOUR

THE GRAND JURORS OF CROCKETT COUNTY, duly empaneled and sworn upon their oath, present that the defendant, APRIL HICKS, between July 1st, 2018 and July 2nd, 2019, and before the finding of this indictment, the defendant, a public servant committed an offense who, with intent to obtain a benefit or to harm another, intentionally or knowingly, committed an act, being the offense of theft, under color of office or employment, that exceeded the public servant's official power, in violation of T.C.A. §39-16-402, a Class E Felony, and against the peace and dignity of the State of Tennessee.

COUNT FIVE

THE GRAND JURORS OF CROCKETT COUNTY, duly empaneled and sworn upon their oath, present that the defendant, **APRIL HICKS**, between July 1st, 2018 and July 2nd, 2019, and before the finding of this indictment, the defendant, a public servant

committed an offense who, with intent to obtain a benefit or to harm another, intentionally or knowingly, violated a law relating to the public servant's office or employment, being the offense of theft, in violation of T.C.A. §39-16-402, a Class E Felony, and against the peace and dignity of the State of Tennessee.

COUNT SIX

THE GRAND JURORS OF CROCKETT COUNTY, duly empaneled and sworn upon their oath, present that the defendant, APRIL HICKS, between July 1st, 2018 and July 2nd, 2019, and before the finding of this indictment, the defendant, a public servant committed an offense who, with intent to obtain a benefit or to harm another, intentionally or knowingly, received a benefit not otherwise authorized by law, by committing theft, in violation of T.C.A. §39-16-402, a Class E Felony, and against the peace and dignity of the State of Tennessee.

COUNT SEVEN

THE GRAND JURORS OF CROCKETT COUNTY, duly empaneled and sworn upon their oath, present that the defendant, **APRIL HICKS**, between July 1st, 2018 and July 2nd, 2019, and before the finding of this indictment, APRIL HICKS, knowingly made a false entry in, or false alteration of, a governmental record, in violation of T.C.A. §39-16-504, a Class E Felony, and against the peace and dignity of the State of Tennessee.

COUNT EIGHT

THE GRAND JURORS OF CROCKETT COUNTY, duly empaneled and sworn upon their oath, present that the defendant, APRIL HICKS, between July 1st, 2018 and

July 2nd, 2019, and before the finding of this indictment, APRIL HICKS made, presented, or used any record, document, or thing with knowledge of its falsity and with intent that it will be taken as a genuine governmental record, in violation of T.C.A. §39-16-504, a Class E Felony, and against the peace and dignity of the State of Tennessee.

COUNT NINE

THE GRAND JURORS OF CROCKETT COUNTY, duly empaneled and sworn upon their oath, present that the defendant, APRIL HICKS, between July 1st, 2018 and July 2nd, 2019, and before the finding of this indictment, APRIL HICKS intentionally and unlawfully destroyed, concealed, removed or otherwise impaired the verity, legibility or availability of a governmental record, in violation of T.C.A. §39-16-504, a Class E Felony, and against the peace and dignity of the State of Tennessee.

I have received and read a copy of the indictment and discussed it with my attorney. My attorney has provided informed me as to the nature of the charges against me, and I understand the nature of the charges. My attorney has further advised me as to the minimum and maximum possible punishment for the crime or crimes. I desire to voluntarily enter a plea of guilty.

I admit that I am guilty of the offense or offenses to which I am pleading guilty. I understand that I could continue with a not guilty plea to any offense charged and that I have a right to a speedy and public trial by jury. I understand I have the right to be represented by an attorney in all stages of the proceedings against me and if I cannot afford an attorney, an appointed attorney would represent me without any cost to me. I understand that if I went to trial I, or my attorney, would have the right to question and cross-examine any witnesses against me, to subpoena witnesses to testify for me, and that I could not be forced to testify at trial and incriminate myself. I also understand I have the right to have a jury impose any fine in excess of \$50.00. I understand that by pleading guilty I give up or waive my right to a jury trial and all the above rights. I also understand that I am giving up or waiving my right to an appeal.

By pleading guilty I understand that I may be questioned regarding the offense or offenses and that I can be punished for perjury if I give false answers under oath.

I understand that any prior convictions I have may be considered by the Court in sentencing. I understand that if I am presently eligible for enhanced sentencing, I have a statutory right to a delay of ten (10) days after the State files a notice of intent to seek enhanced punishment before the Court accepts my plea of "GUILTY". I hereby acknowledge that if I am subject to enhanced sentencing as a multiple, persistent and/or career criminal, I hereby give up my right to the filing of such notice and/or some or all of the ten (10) day waiting period before conviction.

I understand that the conviction or convictions today may be used in a future proceeding to make my punishment greater should I be sentenced in the future for another offense.

I am pleading guilty of my own free will and choice. No force has been exerted on me nor have any threats been made against me to get me to plead guilty. No promises have been made to me other than the details of my guilty plea set forth on the back of this form. I am aware of the action I am taking and request the Court to accept my guilty plea. I waive my right to jury trial and appeal and submit my case to the Trial Judge for full and final determination.

The individual parts of the pleas involved in this package agreement are severable. The parties agree that, should any sentence involved in this negotiation be found to be void, its invalidity shall affect only that individual sentence. The plea of guilty as to that conviction and the pleas for the remaining convictions and sentence involved in the plea agreement shall remain intact.
