And the Grand Jurors aforesaid, upon their oaths aforesaid, do further present: That **JOHNNY CARSON DISHMAN**, a public servant, prior to the finding of this indictment, on or about January 01, 2017 - March 13, 2020, in the County and State aforesaid, did unlawfully, feloniously, intentionally, and knowingly, and with intent to obtain a benefit commit an act, relating to his office or employment that constituted an unauthorized exercise of official power, in violation of T.C.A.§39-16-402, and against the peace and dignity of the State of Tennessee.
