GRINDSTAFF**, on or about September 11, 2009 through on or about June 7, 2019, in the State and County aforesaid and before the finding of this Presentment did unlawfully, feloniously and knowingly obtain or exercise control over property, to wit: US Currency, valued at \$250,000 or more and owned by the Bristol and Bluff City Utility Districts, without the effective consent of the said owner and with the intent to deprive the said owner thereof, contrary to Tennessee Code Annotated, Section 39-14-103, a Class A felony, and against the peace and dignity of the State of Tennessee.

CHARGE: **THEFT OF \$60,000 OR MORE, BUT LESS THAN \$250,000**

COUNT 2

The Grand Jurors for Sullivan County, Tennessee, being duly empaneled and sworn, upon their oath present and say that **TINA L. GRINDSTAFF**, on or about March 30, 2016 through on or about June 21, 2019, in the State and County aforesaid and before the finding of this Presentment did unlawfully, feloniously and knowingly obtain or exercise control over property, to wit: US Currency, valued at \$60,000 or more, but less than \$250,000 and owned by the Bristol and Bluff City Utility Districts, without the effective consent of the said owner and with the intent to deprive the said owner thereof, contrary to Tennessee Code Annotated, Section 39-14-103, a Class B felony, and against the peace and dignity of the State of Tennessee.
