heretofore, to wit, on or between April 1, 2023 and July 31, 2023, before the finding of this indictment, in the County aforesaid, did then and there unlawfully, and knowingly obtain or exercise control over certain property, to wit: US Currency, of the value of more than \$1,000.00 (One Thousand Dollars) but less than \$2,500.00 (Two Thousand Five Hundred Dollars), the property of Oak Ridge High School Softball Boosters, without the effective consent of Oak Ridge High School Softball Boosters, with the intent to deprive Oak Ridge High School Softball Boosters of the property, in violation of Tennessee Code Annotated §39-14-103, against the peace and dignity of the State of Tennessee.

heretofore, to wit, on or between April 1, 2023 and July 31, 2023, before the finding of this indictment, in the County aforesaid, did then and there unlawfully and knowingly use a debit/credit issued by Enrichment Federal Credit Union to Oak Ridge High School Softball Boosters to obtain US Currency, over the value of \$1,000 but less than \$2,500, from Oak Ridge High School Boosters, knowing at the time that the use of the aforesaid credit card was not authorized by the said Oak Ridge High School Boosters, in violation of T.C.A. 39-14-118, against the peace and dignity of the State of Tennessee.
