

# CRIMINAL COURT COUNT 1 (NEW)

The Grand Jurors of the State of Tennessee, duly summoned, elected impaneled, sworn, and charged to inquire in and for the body of the County aforesaid, in the State aforesaid, upon their oath, present that **TRAVIS DALE THRASHER**, on or about March 01, 2023, through June 30, 2024 in the County and State aforesaid and before the finding of this Indictment, did unlawfully and knowingly, while acting as a public servant, commit an offense with intent to obtain a benefit by making purchases not authorized for his personal benefit, in violation of §T.C.A 39-16-402, and against the peace and dignity of the State of Tennessee.

#### **COUNT 2 (NEW)**

And these same Grand Jurors upon their same oath further present that **TRAVIS DALE THRASHER**, on or about March 01, 2023, through June 30, 2024 in the County and State aforesaid and before the finding of this Indictment, did knowingly obtain or exercise control over certain property, to-wit: \$1,022 of United States Currency being a value of more than \$1,000.00 (One Thousand Dollars) but less than \$2,500.00 (Two Thousand Five Hundred Dollars), the property of the City of Oliver Springs, without the effective consent of said victim, with the intent to deprive the owner of the property, in violation of T.C.A. 39-14-103, and against the peace and dignity of the State of Tennessee.
