COUNT ONE

The Grand Jurors of Lawrence County, Tennessee, duly impaneled, and sworn upon their oath, present: That BRADLEY LEE on, about or between 12/7/20 and 12/21/22, in Lawrence County, Tennessee and before the finding of this indictment, did unlawfully and knowingly obtain or exercise control over property, to-wit: \$7944.08, of the value of Two Thousand Five Hundred Dollars (\$2,500.00) or more but less than Ten Thousand Dollars (\$10,000), from Leoma Utility District, without their effective consent, with the intent to deprive the said Leoma Utility District thereof, in violation of Tennessee Code Annotated Section 39-14-103, all of which is against the peace and dignity of the State of Tennessee.

COUNT TWO

The Grand Jurors of Lawrence County, Tennessee, duly impaneled, and sworn upon their oath, present: That BRADLEY LEE on, about or between 7/12/21 and 10/13/22, in Lawrence County, Tennessee and before the finding of this indictment, did knowingly, directly, or indirectly access, cause to be accessed, or attempt to access any telephone system, telecommunications facility, computer software, computer program, data, computer, computer system, computer network, or any part thereof, for the purpose of obtaining money, property, or services for oneself or another by means of false or fraudulent pretenses, representations, or promises, in violation of Tennessee Code Annotated Section 39-14-602, all of which is against the peace and dignity of the State of Tennessee.

COUNT THREE

The Grand Jurors of Lawrence County, Tennessee, duly impaneled, and sworn upon their oath, present: That BRADLEY LEE on, about or between 12/7/20 and 12/21/22, in Lawrence County, Tennessee and before the finding of this indictment, did unlawfully, with the intent to obtain a benefit or to harm another, intentionally or knowingly commit an act relating to the office or employment of BRADLEY LEE that constitutes an unauthorized exercise of official power, to-wit: did take monies in the amount of \$7944.08 from Leoma Utility District (Theft over \$2500), in violation of Tennessee Code Annotated Section 39-16-402(a)(1) all of which is against the peace and dignity of the State of Tennessee.

COUNT FOUR

The Grand Jurors of Lawrence County, Tennessee, duly impaneled, and sworn upon their oath, present: That BRADLEY LEE on or about the 18th day of February, 2022, in Lawrence County, Tennessee and before the finding of this indictment, did, with intent to defraud or harm another, make or alter an object, in whole or in part, so that it appeared to have value because of its age, antiquity, rarity, source or authorship that it did not have (an invoice from Car Country in the amount of \$250.00), in violation of Tennessee Code Annotated Section 39-14-115, all of which is against the peace and dignity of the State of Tennessee.

COUNT FIVE

The Grand Jurors of Lawrence County, Tennessee, duly impaneled, and sworn upon their oath, present: That BRADLEY LEE on or about the 3rd day of March, 2022, in Lawrence County, Tennessee and before the finding of this indictment, did, with intent to defraud or harm another, make or alter an object, in whole or in part, so that it appeared to have value because of its age, antiquity, rarity, source or authorship that it did not have (an invoice from Inservice Towing in the amount of \$250.00), in violation of Tennessee Code Annotated Section 39-14-115, all of which is against the peace and dignity of the State of Tennessee.

COUNT SIX

The Grand Jurors of Lawrence County, Tennessee, duly impaneled, and sworn upon their oath, present: That BRADLEY LEE on or about the 14th day of June, 2022, in Lawrence County, Tennessee and before the finding of this indictment, did, with intent to defraud or harm another, make or alter an object, in whole or in part, so that it appeared to have value because of its age, antiquity, rarity, source or authorship that it did not have (an invoice from Williams Farms in the amount of \$400.00), in violation of Tennessee Code Annotated Section 39-14-115, all of which is against the peace and dignity of the State of Tennessee.

WAIVER OF TRIAL BY JURY
AND
PETITION TO ENTER PLEA OF GUILTY

I, the above-named defendant, pursuant to *Rule 11* of the *Tennessee Rules of Criminal Procedure*, respectfully represent to the Court as follows:

1. I have been advised of my right under the Constitution and laws of this State to a speedy and public trial by a jury of my peers and my right to have a jury impose a fine of over \$50.00. I waive those rights.
2. I have received a copy of the indictment before being called upon to plea, and have read and discussed it with my attorney, and believe and feel that I understand every accusation made against me in this case.
3. I have told my attorney the facts and surrounding circumstances as known to me concerning the matters mentioned in the indictment, and believe and feel that my attorney is fully informed as to all such matters. My attorney has since informed me, and has counseled and advised with me as to the nature and cause of every accusation against me, and as to any and all possible defenses I might have in this case. He has advised me as to the punishment ranges which the law provides. He has informed me that probation may or may not be granted, if eligible for probation, and that if I plead "Guilty" to more than one offense, each indictment being considered as a separate offense, the Court may order the sentences to be served consecutively, one after the other.
4. I understand that I may, if I so choose, plead "Not Guilty" to any offense charged against me, and that if I choose to plead "Not Guilty" the Constitution guarantees me (a) the right to a speedy and public trial by jury; (b) the right to see and hear all witnesses against me; (c)

the right to use the power and process of the Court to compel the production of any evidence, including the attendance of any witnesses, in my favor; (d) the right not to be compelled to incriminate myself; and, (e) the right to have the assistance of counsel in my defense at all stages of the proceedings and that if I cannot afford counsel, counsel will be appointed for me at no cost.

☐ I waive my right to have counsel appointed for me.

5. I declare that no officer or agent of any branch of government, nor any other person, has made any promise or suggestion of any kind to me, or within my knowledge to anyone else except the agreement to recommend the sentence as set out below.
6. I understand the proceedings in this case against me and would ask questions if I had any.
7. I know the Court will not accept a plea of "Guilty" from anyone who claims to be innocent and, with that in mind and because I make no claim of innocence, I wish to plead "Guilty" and respectfully request the Court to accept my plea and the recommendation of the State as follows:

I understand that any probation might be revoked for failure to pay said fine and/or costs, but I am sure that I can do so within the time set out above.

8. I declare that I offer my plea of "Guilty" freely and voluntarily and of my own accord and I feel and believe I understand the charges against me.

9. I understand that, except for the right to counsel, by pleading "Guilty" I am waiving the rights set out in paragraph (4) above including my right to trial by jury and that I waive my right to appeal this conviction to any appellate court.

☐ I hereby waive my rights which I may have to petition this Honorable Court for early release from my incarceration pursuant to *Tennessee Code Annotated §40-35-212(d)* and hereby acknowledge and agree that my sole avenue to pursue early release shall be through any hearings that may be properly scheduled before the

Tennessee Board of Pardons and Paroles. I agree that their decisions shall be dispositive upon any issues regarding my early release and rely upon that avenue for release fully.

The individual parts of the pleas involved in this package agreement are severable. The parties agree that, should any sentence involved in this negotiation be found to be void, its invalidity shall affect only that individual sentence. The plea of guilty as to that conviction and the pleas for the remaining convictions and sentence involved in the plea agreement shall remain intact.
