COUNT 1

The Grand Jurors upon their oath do present that

BOBBY MACK WOODS

between the 9th day of February, 2022 and 28th day of November, 2023, in Monroe County, Tennessee, and before the finding of this indictment, did unlawfully and knowingly, while being a public servant, to wit: patrol officer with the Madisonville Police Department, intentionally or knowingly with intent to obtain a benefit, did commit an act relating to the servant's office or employment that constitutes an unauthorized exercise of official power or received any benefit not otherwise authorized by law, in violation of T.C.A. 39-16-402, all of which is against the peace and dignity of the State of Tennessee.

COUNT 2

The Grand Jurors upon their oath do present that

BOBBY MACK WOODS

between the 9th day of February, 2022 and 28th day of November, 2023, in Monroe County, Tennessee, and before the finding of this indictment, did unlawfully and knowingly exercise control over property, the value of two thousand five hundred dollars (\$2,500) or more but less than ten thousand dollars (\$10,000), of City of Madisonville without effective consent, with intent to deprive the said City of Madisonville thereof, in violation of T.C.A. 39-14-103, all of which is against the peace and dignity of the MAY 07 2025 State of Tennessee.

COUNT 3

The Grand Jurors upon their oath do present that

BOBBY MACK WOODS

between the 9th day of February, 2022 and 28th day of November, 2023, in Monroe County, Tennessee, and before the finding of this indictment, with fraudulent intent, did unlawfully, without the consent of the owner or issuer, use or allow to be used a credit or debit card, or information from a credit or debit card, the property of City of Madisonville, to obtain property, credit, services or anything else of value, two thousand five hundred dollars (\$2,500) or more but less than ten thousand dollars (\$10,000) in value, with knowledge that the card or information from that card was forged or stolen, in violation of T.C.A. 39-14-118, all of which is against the peace and dignity of the State of Tennessee.
