#### COUNT ONE

The Grand Jurors for the State of Tennessee, having been duly summoned, elected, impaneled, sworn, and charged to inquire for the body of the County and State aforesaid, present that LEAHLA HANCE between August 01, 2024 and February 25, 2025, before the finding of this indictment in the State and County aforesaid, did unlawfully, feloniously and knowingly exercise control over property, to-wit: unearned salary, the value of two thousand five hundred dollars (\$2,500) or more but less than ten thousand dollars (\$10,000), the property of the Cocke County Government, without effective consent of the Cocke County Government, with intent to deprive the Cocke County Government thereof, in violation of T.C.A. 39-14-103, contrary to the statute and against the peace and dignity of the State of Tennessee.

### COUNT TWO

The Grand Jurors for the State of Tennessee, having been duly summoned, elected, impaneled, sworn, and charged to inquire for the body of the County and State aforesaid, present that LEAHLA HANCE between August 01, 2024 and February 25, 2025, before the finding of this indictment in the State and County aforesaid, did unlawfully, feloniously and knowingly forge a writing, to-wit: time cards, with intent to defraud or harm another, to-wit: Cocke County Government, in violation of T.C.A. 39-14-114, contrary to the statute and against the peace and dignity of the State of Tennessee.

#### COUNT THREE

The Grand Jurors for the State of Tennessee, having been duly summoned, elected, impaneled, sworn, and charged to inquire for the body of the County and State aforesaid, present that LEAHLA HANCE between August 01, 2024 and February 25, 2025, before the finding of this indictment in the State and County aforesaid, being a public servant with the intent to obtain a benefit or to harm another, did unlawfully, feloniously, intentionally or knowingly commit an act relating to the servant's office or employment that constitutes an unauthorized exercise of official power, commit an act under color of office or employment that exceeds the servant's official power, refrains from performing a duty that is imposed by law or that is clearly inherent in the nature of the public servant's office or employment, violates a law relating to the public servant's office or employment or receives any benefit not otherwise authorized by law, while employed as a deputy with the Cocke County Sheriff's Department, in violation of T.C.A. 39-16-402, contrary to the statute, and against the peace and dignity of the State of Tennessee.

#### COUNT FOUR

The Grand Jurors for the State of Tennessee, having been duly summoned, elected, impaneled, sworn, and charged to inquire for the body of the County and State aforesaid, present that LEAHLA HANCE between August 01, 2024 and February 25, 2025, before the finding of this indictment in the State and County aforesaid, did unlawfully, feloniously and intentionally make a false entry in or false alteration of a governmental record, or make, present, or use any record, document or thing with knowledge of its falsity and with intent that it will be taken as a genuine governmental record, or destroy, conceal, remove, or otherwise impair the verity, legibility, or availability of a governmental record, in violation of T.C.A. 39-16-504, contrary to the statute, and against the peace and dignity of the State of Tennessee.
