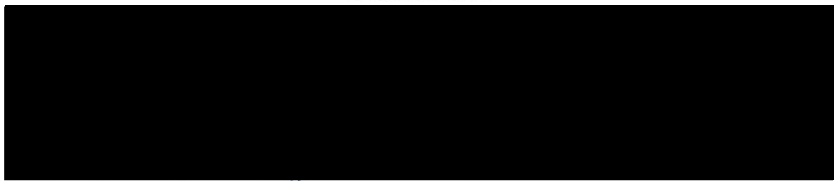

CHARGE: THEFT OF PROPERTY - \$2,500 TO < \$10,000

The Grand Jurors for the State of Tennessee, upon their oaths, present that **LEIGH-ANNA RENEE CLARK** between the 1st day of March, 2023 and the 26th day of January, 2024, in the State and County aforesaid, did commit the offense of theft of property by knowingly obtaining or exercising control over two thousand five hundred dollars (\$2,500.00) or more of monetary funds from Pioneer Wrestling Booster Club as its president without the effective consent of the Booster Club and with the intent to deprive the Booster Club thereof; a class D Felony, in violation of Section 39-14-103 of the Tennessee Code Annotated, and against the peace and dignity of the State of Tennessee.

COUNT TWO

CHARGE: THEFT OF PROPERTY - \$2,500 TO < \$10,000

And the Grand Jurors aforesaid, upon their oaths aforesaid, do further present that **LEIGH-ANNA RENEE CLARK** between the 1st day of March, 2023 and the 26th day of January, 2024, in the State and County aforesaid, did unlawfully, commit the offense of theft of property by knowingly obtaining or exercising control over two thousand five hundred dollars (\$2,500.00) or more of monetary funds from Pioneer Football Booster Club as its president without the effective consent of the Booster Club and with the intent to deprive the Booster Club thereof; a class D Felony, in violation of Section 39-14-103 of the Tennessee Code Annotated, and against the peace and dignity of the State of Tennessee.

COUNT THREE

CHARGE: FORGERY

And the Grand Jurors aforesaid, upon their oaths aforesaid, do further present that **LEIGH-ANNA RENEE CLARK** between the 18th day of December, 2023 and the 12th day of January, 2024, in the State and County aforesaid, did unlawfully, commit the offense of forgery by knowingly and with the intent to defraud another, forge a letter so that it purports to be the act of Eastman Credit Union, where Eastman Credit Union did not authorize that act; a class E Felony, in violation of Section 39-14-114 of the Tennessee Code Annotated, and against the peace and dignity of the State of Tennessee.
