

CRIMINAL DOCKET NUMBER:

COUNT ONE

The Grand Jurors of GILES County, Tennessee, duly impaneled, and sworn upon their oath, present: That ASHLEY SPRY STOGNER between the 23rd day of August, 2021 and the 10th day of September, 2024, in GILES County, Tennessee and before the finding of this indictment, did unlawfully and knowingly obtain or exercise control over certain property, to wit: U.S. currency, of the value of more than \$60,000.00 (Sixty Thousand Dollars) but less than \$250,000.00 (Two Hundred and Fifty Thousand Dollars), the property of City of Minor Hill, without the effective consent of City of Minor Hill, with the intent to deprive City of Minor Hill of the property, in violation of Tennessee Code Annotated Section 39-14-103, all of which is against the peace and dignity of the State of Tennessee.

COUNT TWO

The Grand Jurors of GILES County, Tennessee, duly impaneled, and sworn upon their oath, present: That ASHLEY SPRY STOGNER between the 23rd day of August, 2021 and the 10th day of September, 2024, in GILES County, Tennessee and before the finding of this indictment, did unlawfully, knowingly, and with the intent to defraud the City of Minor Hill, forge and make a certain paper writing of the following tenor, words and figures, to wit: paychecks, so that the said paper writing purported to bear a signature not so that the said paper writing purported to bear a signature not authorized as drawer, in violation of Tennessee Code Annotated Section 39-14-114, all of which is against the peace and dignity of the State of Tennessee.

COUNT THREE

The Grand Jurors of GILES County, Tennessee, duly impaneled, and sworn upon their oath, present: That ASHLEY SPRY STOGNER between the 23rd day of August, 2021 and the 10th day of September, 2024, in GILES County, Tennessee and before the finding of this indictment, did unlawfully and knowingly, while being a public servant, to wit: City Recorder for the City of Minor Hill, did knowingly with intent to obtain a benefit commit an act relating to the servant's office or employment that constitutes an unauthorized exercise of official power or exceeds the servant's official power or refrains from performing a duty that is imposed by law or that is clearly inherent in the nature of the public servant's office or employment, in violation of Tennessee Code Annotated Section 39-16-402, all of which is against the peace and dignity of the State of Tennessee.

COUNT FOUR

The Grand Jurors of GILES County, Tennessee, duly impaneled, and sworn upon their oath, present: That ASHLEY SPRY STOGNER between the 23rd day of August, 2021 and the 10th day of September, 2024, in GILES County, Tennessee and before the finding of this indictment, did unlawfully and knowingly make a false entry in, or false alteration of, a governmental record; and/or make, present, or use any record, document or thing with knowledge of its falsity and with intent that it will be taken as a genuine governmental record, and/or destroyed, concealed, removed, or otherwise impaired the verity, legibility, or availability of a governmental record, in violation of Tennessee Code Annotated Section 39-16-504, all of which is against the peace and dignity of the State of Tennessee.

COUNT FIVE

The Grand Jurors of GILES County, Tennessee, duly impaneled, and sworn upon their oath, present: That ASHLEY SPRY STOGNER between the 23rd day of August, 2021 and the 10th day of September, 2024, in GILES County, Tennessee and before the finding of this indictment, did unlawfully and knowingly directly or indirectly accessed or caused to be accessed, or attempted to access any telephone system, telecommunications facility, computer software, computer program, data, computer, computer system, computer network, or any part thereof, for the purpose of: obtaining money, property, or services for oneself or another by means of false or fraudulent pretenses, representations, or promises, in violation of Tennessee Code Annotated Section 39-14-602(A)(i), all of which is against the peace and dignity of the State of Tennessee.

COUNT SIX

The Grand Jurors of GILES County, Tennessee, duly impaneled, and sworn upon their oath, present: That ASHLEY SPRY STOGNER between the 1st day of March, 2022 and the 3rd day of May, 2024, in GILES County, Tennessee and before the finding of this indictment, did unlawfully and knowingly obtain or exercise control over certain property, to wit: U.S. currency, of the value of more than \$1,000 (one thousand dollars), but less than \$2500 (two thousand five hundred dollars), the property of Minor Hill Utility District, without the effective consent of Minor Hill Utility District, with the intent to deprive Minor Hill Utility District of the property, in violation of Tennessee Code Annotated Section 39-14-103, all of which is against the peace and dignity of the State of Tennessee.

COUNT SEVEN


The Grand Jurors of GILES County, Tennessee, duly impaneled, and sworn upon their oath, present: That ASHLEY SPRY STOGNER between the 1st day of March, 2022 and the 3rd day of May, 2024, in GILES County, Tennessee and before the finding of this indictment, did unlawfully, knowingly, and with the intent to defraud the Minor Hill Utility District, forge and make a certain paper writing of the following tenor, words and figures, to wit: checks, so that the said paper writing purported to bear a signature not so that the said paper writing purported to bear a signature not authorized as drawer, in violation of Tennessee Code Annotated Section 39-14-114, all of which is against the peace and dignity of the State of Tennessee.

COUNT EIGHT

The Grand Jurors of GILES County, Tennessee, duly impaneled, and sworn upon their oath, present: That ASHLEY SPRY STOGNER between the 1st day of March, 2022 and the 3rd day of May, 2024, in GILES County, Tennessee and before the finding of this indictment, did unlawfully and knowingly, while being a public servant, to wit: Bookkeeper of Minor Hill Utility District, did knowingly with intent to obtain a benefit commit an act relating to the servant's office or employment that constitutes an unauthorized exercise of official power or exceeds the servant's official power or refrains from performing a duty that is imposed by law or that is clearly inherent in the nature of the public servant's office or employment, in violation of Tennessee Code Annotated Section 39-16-402, all of which is against the peace and dignity of the State of Tennessee.

COUNT NINE

The Grand Jurors of GILES County, Tennessee, duly impaneled, and sworn upon their oath, present: That ASHLEY SPRY STOGNER between the 1st day of March, 2022 and the 3rd day of May, 2024, in GILES County, Tennessee and before the finding of this indictment, did unlawfully and knowingly make a false entry in, or false alteration of, a governmental record; and/or make, present, or use any record, document or thing with knowledge of its falsity and with intent that it will be taken as a genuine governmental record, and/or destroyed, concealed, removed, or otherwise impaired the verity, legibility, or availability of a governmental record, in violation of Tennessee Code Annotated Section 39-16-504, all of which is against the peace and dignity of the State of Tennessee.
