The Perfect Storm

The pandemic taught us many lessons about ourselves and our organizations: we are resourceful, innovative, hardworking, and resilient. Unfortunately, it also highlighted that sometimes we are woefully unprepared. While much of the last 3 years has been reactionary, the pandemic is seemingly now behind us, and the path ahead provides us with an opportunity to assess lessons learned and to prepare for the next crisis. As financial management experts for your county, you play a significant role in that preparation.

Evaluate internal controls – Effective internal controls are vital to ensuring that local governments achieve their objectives while also safeguarding their assets. Management should evaluate internal controls regularly to ensure that office practices align with written controls and that the framework implemented provides reasonable assurance of financial report accuracy while also detecting fraud and errors. Aside from a complete lack of controls, the most common failure in internal controls is management and employee override. Simply put, a control exists on paper, but not in practice. Take some time to contemplate if the controls you have in place make sense, work as intended, and provide the most assurance of protecting government assets while delivering quality services to the citizens of your local government.

Perform Risk Assessments – I like to call this "think like a thief." If I am an employee or a citizen with nefarious intentions, where can I take advantage with the most ease and the least detection? Fraudsters are adept at seeking out

weaknesses and taking advantage of opportunities. During times of crisis these opportunities are more prevalent as emergency funding must be administered quickly, management is more distracted, and controls are more likely to fail. This creates a breeding ground for fraud, waste, and abuse. With unprecedented amounts of federal funding flowing to governments amidst the COVID pandemic, we have seen an influx in fraud schemes and improper payments so assess your risk and respond accordingly. As part of this assessment, don't forget about cybersecurity! Technology is a wonderful tool when wielded properly, but it can also make our information and resources vulnerable if not properly protected. Train Your People – Lastly, take every opportunity to strengthen your existing skills, learn new ones, and cross train employees. The pandemic forced most organizations and their employees to adapt their roles by taking on new job responsibilities, modernizing customer experiences, and at times, completely changing the way we do business. Learning these skills on the fly during a crisis is not ideal. Instead, invest the resources and efforts now to strengthen and empower your workforce to ensure we have the flexibility in place to adapt to the next crisis. Proper training and investment in your people create a culture of trust, agility, and success when faced with adversity.

As we emerge from one storm, take advantage of the calm. Use your time and resources wisely and learn from past mistakes so during the next crisis you can weather the storm.


