# **Higher Education**

#### **Tennessee Promise**

(Full Evaluation - July 2020, Update - March 2021)

OREA completed an extensive evaluation of the Tennessee Promise Scholarship Program, which was created by the General Assembly in 2014 to give more high school graduates an opportunity to earn an associate degree or technical diploma. Since OREA's initial evaluation was completed in July 2020, OREA has published a short brief with updated key metrics. **tncot.cc/promise**

# **PreK-12 Education**

## **How Much Tennessee Public Schools Spend Per Student** (*March 2021*)

OREA's 2021 report examines the first year of school level per-pupil expenditure data published for the 2018-19 school year as required by the federal Every Student Succeeds Act (ESSA). An interactive dashboard and accompanying map on OREA's website allow users to view the 2018-19 school year per-pupil figures for all Tennessee school districts and K-12 public schools. **tncot.cc/perpupil** 



#### Student Attendance in Tennessee (March 2021)

OREA's 2021 report analyzes data on chronic absenteeism and truancy, evaluates efforts to address student absenteeism, and identifies successful strategies used by districts. **tncot.cc/attendance** 



#### School Resource Officer in Tennessee (April 2021)

This legislative recap summarizes the changes made in Public Chapter 154 (2019), which created school safety grants. The grant program supported the placement of 213 new full-time school resource officers in schools during the 2019-20 school year; 57 districts received grant funding that year. **tncot.cc/SRO**

# **PreK-12 Education**

#### **Mapping Tennessee Education**

The Mapping Tennessee Education portal is updated annually and contains K-12 education data for the 2019-20 school year, the latest year of data available. The website includes several interactive maps:

- all schools and school districts by both House and Senate legislative district;
- percent increase in average classroom salary from 2019 to 2020 by district;
- average classroom teacher salary by district;
- type of school district; and
- private schools. tncot.cc/mappingeducation

#### **Basic Education Program (BEP) Calculator**

OREA has addressed the need for independent verification, increased transparency, and greater public understanding of the Basic Education Program, the state's K-12 education funding formula. The BEP Calculator, available on the Comptroller's website, reconstructs the entire BEP calculation from scratch. The calculator provides a step-by-step look at the entire BEP calculation for any combination of districts and counties, and gives users the ability to run various "what if?" scenarios. Users can adjust unit costs and funding ratios, such as teacher salaries and insurance premiums, to see the impact of different inputs on state and local BEP money. **tncot.cc/BEP**

## **Financial Exploitation of the Elderly in Tennessee** (October 2020)

OREA's report provides background information about the issue of elder financial exploitation, summarizes relevant research, and describes the legislation that the General Assembly has passed over the last five years in an effort to address elder financial exploitation in Tennessee. The report also includes an evaluation of the state's patchwork of state and local entities that protect elderly Tennesseans, including Adult Protective Services – the agency most closely associated with issues concerning elder abuse. The report addresses stakeholder views about potential gaps that remain in the system, as well as noting areas of progress. It concludes with policy options for consideration by the General Assembly and relevant stakeholders. **tncot.cc/exploitation**

#### State Benefits for Veterans in Tennessee (March 2021)

In this report, OREA details more than 40 benefits, services, and protections for veterans and their families that are provided by state agencies. Data is included on the number of veterans receiving the benefit, the state expenditures to provide the benefit or the revenue forgone when state fees are waived or discounted for veterans, and the number of other states providing similar benefits. In fiscal year 2019-20, recurring state-funded benefits and services totaled at least \$30.3 million for Tennessee's 461,000 veterans. tncot.cc/VA
