In addition to the base funding amount, TISA provides additional funding to students based on their individual needs, known as weighted funding. Weights are represented as percentages of the TISA base funding established for each school year, and students may qualify for multiple weights and generate funding for each weight. Students with disabilities, English learners, and students with characteristics of dyslexia generate additional weighted funding, as well as students classified as economically disadvantaged or enrolled in districts that meet certain criteria. Unique learning needs (ULNs) are divided into 10 categories, each with an assigned percentage weight of the TISA base allocation.
