State law requires you to complete and file this form with the Assessor of Property in the county in which you own a mineral interest. If you previously recorded your mineral interest deed you may provide the book and page. If the deed is not recorded you may provide a copy for the Assessors' records.

Mineral properties are subject to taxation pursuant to Article II, Section 28, of the Tennessee Constitution and Tennessee Code Annotated §§ 67-5-101 and 67-5-502(d).

For purposes of property assessments, a "mineral" is defined as "any substance with economic value, whether organic or inorganic that can be extracted from the earth, including industrial minerals but excluding products of the soil." The term "mineral" includes, but is not limited to barite, bauxite, clay, coal, copper, dolomite, dimension stone, feldspar, fluorspar, gold, iron, lead, manganese, marble, natural gas, oil, perlite, phosphate, pyrites, sandstone, shale, silica, silver, strontium, tin, titanium, zinc and zirconium. The term "mineral" does not include products of the soil. The term "products of the soil" includes but is not limited to crops, timber, nursery stock, shrubs, flowers, ornamental trees.

A SEPARATE SCHEDULE MUST BE FILED FOR <u>EACH PARCEL</u>. THE INFORMATION THAT MUST BE PROVIDED IS FOR THE PERIOD FROM <u>JANUARY 1, TO DECEMBER 31</u>. ALL SECTIONS OF THE SCHEDULE MUST BE COMPLETED. IF A QUESTION OR SECTION IS "NOT APPLICABLE," SO STATE.
