## TENNESSEE STATE FUNDING BOARD

### NOTICE OF MEETING

**JUNE 22, 2026**

The Tennessee State Funding Board (the “Board”) is scheduled to meet Monday, June 22, 2026, at 2:00 p.m. CT, in the Volunteer Conference Center, 2<sup>nd</sup> Floor, Cordell Hull Building, 425 Rep. John Lewis Way N., Nashville, Tennessee. Board members will be allowed to participate through electronic means.
